1. **NAME OF THE ASSOCIATION** : SOCIETY FOR RURAL AGRICULTURISTS AND MASS AWARENESS (SRAMA)

2. **LOCATION** : D.No. 4-1, Alamuru, Alamuru Mandal,
E.G. Dt., A.P. INDIA

3. Aims and Objects

- (i) To develop social contacts and spirit if fellow feeling among its members and to maintain a Library with good books, periodicals and newspapers
- (ii) To develop fellow feeling among the members
- (iii) To strive for the eradication of illiteracy by establishing Adult education centres.
- (iv) To develop the social and cultural activities for the welfare of the society
- (v) To utilize the empowerment of youth for the development of the country.
- (vi) To establish the Adult education schools and to promote the adult education.
- (vii) To agricultural, animal husbandry, dairy, polutry and fishery units and give training the above units, where as to create second line income for Fishermen community, Rural poor and neglected women and Micro Entrepreneur ship activities.
- (viii) To promote the sanitation, drinking water, water sheds, de-silting tanks, Income generation activities in Rural and Urban areas.



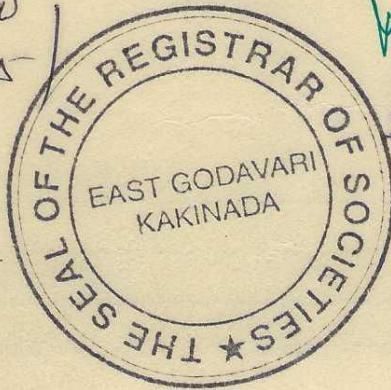

RULES AND REGULATIONS

1. **NAME OF THE ASSOCIATION** : SOCIETY FOR RURAL AGRICULTURISTS AND MASS AWARENESS (SRAMA)

2. **LOCATION** : D.No. 4-1, Alamuru, Alamuru Mandal, E.G. Dt., A.P. INDIA

3. MEMBERSHIP

The membership in this society is open to all who have completed the age of 18 years. The admission fee is Rs. 100/- only. Monthly subscription is Rs. 100/- (Rupees one hundred only) for the members who are enrolled themselves as members in the Association. If an complaint is received against the Members, they shall be removed from the association by the General Body. The membership of the association shall cease in the case of failure to pay the subscription continuously for a period of 3 months and if any behavior of any members is found detrimental to the interest of the Association, such member shall also be removed by the General Body.

4. GENERAL BODY AND ITS FUNCTIONS

- a) To Elect 7 members as Managing Committee
- b) To approve expenditure statement of the previous year and pass the budget for the ensuing year.
- c) To approve the annual report of the Association
- d) To appoint an Auditor if necessary
- e) The General body shall usually meet once in a year in the month of January

5. EXECUTIVE COMMITTEE AND ITS FUNCTIONS :


- a) The Executive committee shall consists of members elected by the General Body viz., President, Vice-President, Secretary, Joint Secretary, Treasurer and 2 members totalling 7 members
- b) The Executive committee shall be responsible for the implementation of the resolutions passed by the General Body.
- c) The Executive Committee shall meet once in a month and review the functioning and the activities of the Association.
- d) The Executive Committee will be elected every year by the General Body.
- e) Any vacancy caused in the Executive committee shall be filled up by the Co-option for the residuary period.

6. DUTIES OF THE OFFICE BEARERS :

1. **President** : He shall be the sole authority. He shall preside over all the meetings of the Association. He shall have casting vote in case of tie. He shall be constitution head of the Society. He shall keep contact with the Society always. He shall closely watch the administrative and other measures directly affecting the interests of the members and initiate suitable action. He shall exercise all the powers of the Managing Committee, in case of emergency. He shall appoint, dismiss, suspend or otherwise punish any salaried employee of the Institution. He will accept the resignation of members. He will supervise the punctual payments of fees etc., He will sanction all the expenditure. He will provide better facilities and better amenities to the members, pupils and staff. He will take such suitable steps as and when necessary to suggest the financial and economic positions of the society. He shall attend to daily correspondence. He is authorised by the organisation to open bank accounts along with the secretary and also



2. **Vice President** : In the absence of the President, the Vice-President shall perform the functions of the President
3. **Secretary** : The Secretary shall be incharge of the day to day administration of the organisation including the correspondence and preservation of records, circulation of notices to the members of the proceedings of the managing committee as well as the General body. He shall record minutes of the meetings of the general body and the managing committee he can also convince the meetings of the managing committee and the general body with the concurrence and consent of the president. He shall have the power to notify the defaulters and remove them from the organisation roles incase they fail to pay the arrears with 10 days of such notice. The secretary shall take the decisions with the help of President is final. He is empowered by the organisation to open bank accounts along with the president and also look after all the bank transactions of the organisation such as to keep the funds of the society either in Banks, Post Offices or with any organisation. He shall sign on cheques for withdrawal of money. He shall have power to receive contributions, donations, within India or Abroad. He is the competent authority to sign on the demand drafts etc. In any case, for any difference in cash account the secretary and president both will be responsible for the same.
4. **Joint Secretary** : In the absence of the Secretary, the Joint-Secretary shall perform the functions of the Secretary.
5. **Treasurer** : He shall receive all the donations and contributions etc. He shall expend the amount after passing receipts and maintain accounts with the permission of the President and Secretary. He shall open savings bank deposits and withdraw whenever necessary and spent the amount to an extent of Rs. 1000/- (Rupees One thousand only) per month in the matter of urgent, necessary and it should be rectified in the next General Body meeting. In any case, for any difference in cash account the Treasurer will be responsible for the same.
7. **Quorum** :
The quorum for the General Body should be 3/5th of the members on roll and to the Executive committee is should be 3/5th
8. **FUNDS** :
All contributions and donations collected from State & Central Governments, abroad or from Public and other Non-Governmental organisations or accepted shall usually form general funds of the Association. The funds shall be spent only for the attainment of the objects of the Association and no portion thereof shall be paid or transferred to any of its members directly or indirectly through any means.
9. **AMENDMENTS** :
The Association here by established shall be one to which the provisions of Sec 12A and Sec 80G of Income tax 1961 or any replacement reenactment of modification there of for the time being inforce may apply so that any donation made there of may be recognised as eligible for exemption or relief from tax in the hands of donor, No amendment to add or delete any rules or clauses of this deed or memorandum and rules and regulations of the Association shall be made without prior approval of the Hon'ble commissioner of Income Tax, Andhra Pradesh
10. **WINDING UP** :
In case the society has to be wound up, it shall be governed by Sections 24 to 25 of the A.P. Societies Registration Act, 2001 (A.P. Act 35/2001) and that the property/funds of the society that will remain after full satisfaction of the liabilities of the society will be transferred or paid to some other institution having similar aims and objects and which is having provision under Section 12A of I.T. Act 1961, 80 G (5) with the Provisions of 35 AC, 35 (i) (ii) and 10(23C) IV & V and permitted under FCRA, 1971 as resolved by the General Body.
11. There is no Commercial motive or business in forming the society.






